

Bids must be submitted to the **Ministry of Home Affairs, Communication and Law, Madhesh Pradesh, Janakpurdham, Dhanusha** via **www.bolpatra.gov.np/egp** before **12:00 pm on 09 May, 2024 (27/01/2081)**. Bids received after this deadline will be rejected. (Note: Only online bids will be accepted)
10. The Bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00 pm on 09 May, 2024(27/01/2081)** at the **Ministry of Home Affairs, Communication and Law, Madhesh Pradesh**. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amounting to a minimum of **Nrs.3,95,000**, which shall be valid for 30 days beyond the validity period of the bid .
11. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bids submission.
